Terms and Conditions:

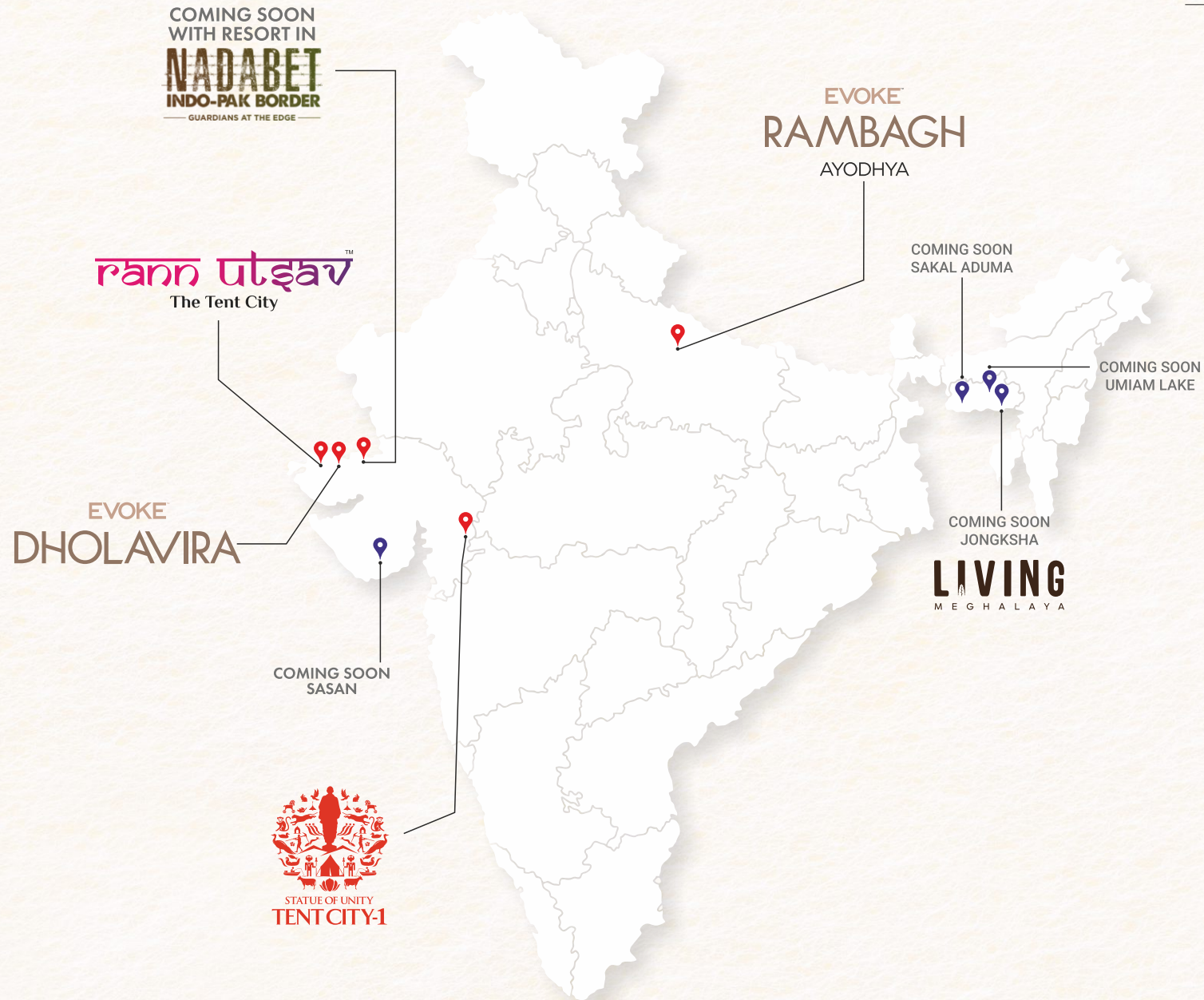
1. These Terms and Conditions, including the associated incentive structure, apply uniformly to all existing properties operated under the Eyak Ventures, as well as any new properties added or brought under management during the current financial year (April 2026 to March 2027). No separate or additional agreements will be required unless specifically notified in writing by the management. All stakeholders are deemed to have accepted these terms upon commencing or continuing engagement during the defined period.
2. The Program is open to channel partners who are actively involved in bookings for tour package travel services through Eyak Ventures.
3. Enrollment is free and can be completed by registering through the link generated on evplbooking.com.
4. Channel partners must provide accurate registration information while registering with us.
5. Channel partners must sign and complete the agreement details to process and avail of the Program.
6. Only one account per individual or agency is permitted; duplicate accounts may result in disqualification.
7. Eyak Ventures reserves the right to refuse or terminate participation at its sole discretion if eligibility criteria are not met or if fraudulent activity is suspected.
8. No channel partner commission and incentive shall be applicable to extra mattress bookings.
9. Various Benefits of Channel partner loyalty program will start after completion of first Quarter.
10. "Vouchers will be issued, generated, or utilized only upon completion of the quarterly incentive calculation."
11. Vouchers are awarded at the discretion of Eyak Ventures Private Limited and are subject to minimum booking thresholds.
12. Vouchers will be credited to your account on evplbooking.com after the qualifying activity (e.g., completion of booking nights as per the incentive structure).
13. Vouchers are valued at either cancellation, modification, or room upgrade and can be redeemed up to the maximum amount mentioned.
14. Vouchers are non-transferable, non-exchangeable, and cannot be redeemed for cash.





15. Each voucher will have a unique code and expiry date, which will be clearly indicated upon issuance; expired vouchers are void and cannot be reinstated.
16. Each Issued voucher can not be redeemed in parts.
17. To redeem a voucher, log in to the online portal (evplbooking.com) using your account credentials and voucher details.
18. Vouchers may only be applied to eligible services as determined by Evoke Experiences.
19. The validity of the voucher will be calculated from the date of issue of Voucher.
20. Each Tent upgrade voucher can be used to upgrade only 1 Tent/ Room/Cottage at a time. Multiple vouchers cannot be combined to upgrade multiple Tent/Room/ Cottage in Single Transaction.
21. Vouchers cannot be combined or used with other discounts, promotions, settlement of accounts or offers unless explicitly permitted.
22. The additional incentive shall be calculated at the end of each financial quarter based on the actual number of guest checked-in nights recorded during that quarter. The applicable incentive percentage will correspond to the respective slab achieved as per the total check-in nights. For example, if at the end of the first quarter, the total number of check-in nights falls within a certain slab, and the applicable additional incentive is a specific percentage, then that percentage shall be calculated on the total booking amount payable for those check-in nights, net of the standard basic commission. At the end of each subsequent quarter, a similar exercise will be conducted. If the cumulative performance qualifies for a higher slab, then the higher incentive percentage shall be applied to the current quarter's eligible check-in bookings (net of basic commission), and an additional percentage (i.e., the differential from the previously paid percentage) shall also be disbursed for the previous quarter's eligible check-in bookings, thereby aligning past incentives with the revised slab. This mechanism will be followed consistently at the end of each financial quarter, ensuring that any upward adjustments in incentive slabs are retroactively applied to all preceding quarters within the same financial year.
23. The validity of this Channel Partner Loyalty Program is limited to the current financial period year only i.e. from April 2026 to March 2027.
